What does this mean for CTE Programs?

- ◇ Admin under pressure because letter grade impacts enrollment, recruitment, retention, morale
- ◇ New rules means 20% of their letter grade based on college and career readiness
- ◇ Support of CTE directors to offer more diverse CTE programs
- ◇ Principals more likely to add CTE programs that appeal to college ready students
- ◇ Additional resources for CTE programs
- ◇ In students completing CTE programs at their high school & central programs
- ◇ TSA success would be very important
- ◇ ECAP utilized to ensure students are college and career ready in 9th grade CTE enrollment

- ◇ Some districts may require completion of CTE course for graduation
- ◇ Students will be required or incentivized to complete the FASFA
- ◇ Students may be required to take the ASVAB
- ◇ Schools may adopt new criteria for valedictorian or other honors
- ◇ ADE may re-evaluate how many years programs with lower retention rates in dual enrollment opportunities
- ◇ Satellites may work more closely with central campus to ensure transportation is accessible
- ◇ Charter school enrollments in CTE will increase
- ◇ Work based learning experiences may expand
