

AZ 2024 CTE Month® PSA Rules and Requirements



Contest Purpose:

To promote Career and Technical Education during CTE Month® to increase awareness and understanding of the benefits of CTE.

Who Can Enter:

The contest is open to secondary and postsecondary CTE students in film and video production classes, or other CTE courses. Students may enter as individuals or as a group.

Contest Awards:

ACTEAZ will announce the winning PSA on February 1, 2024 on our website and social media pages.

Grand Prize

\$500 awarded to the Team or Student Video will be publicized on ACTEAZ media outlets Video will be shown at the 2024 Arizona CTE Summer Conference

Second Place

\$250 awarded to the Team or Student Video will be publicized on ACTEAZ media outlets

Third Place

\$150 awarded to the Team or Student Video will be publicized on ACTEAZ media outlets



2024 CTE Month[®] PSA Rules and Requirements



Video Requirements:

- You must incorporate the CTE Month logo into the PSA. The logo must be an exact reproduction of the graphic provided, can be used in color or black and white, and may not be reproduced smaller than 125 screen pixels in diameter. To download the CTE Month logo, click <u>here</u>.
- You must incorporate the following message into your PSA, presented as on-screen text and/or spoken by talent: "Learn more about Career and Technical Education at acteaz.org."
- Use no other web addresses or logos in the PSA.
- PSA may run up to 180 seconds (3 minutes) in length, including a 5-second slate with a PSA title, your team's name, school name, and the year.
- All team members, and each person whose image and/or voice is used in the PSA <u>must</u> have a signed release form. Students under the age of 18 must have a parent's or guardian's signature on the release form. All forms must be submitted for the PSA to be accepted. If forms are not submitted, the entry will be disqualified.

PSA Policy:

The CTE Month logo can be used only for PSA purposes; all other usage is prohibited.

ACTEAZ retains the copyright on any submitted material and reserves the right to use the material in any way or format it sees fit. ACTEAZ is not responsible for lost, damaged, incorrectly encoded, incorrectly uploaded, mislabeled, or misdirected entries. Entries will not be returned and will become the property of ACTEAZ. PSA entries cannot be used for any commercial activity.

Submitting Your PSA:

- PSAs must be submitted in HD (1080p preferred).
- Include a 5-second slate with a PSA title, your name, school name, and the year.
- PSAs are to be submitted via online through the ACTEAZ website. Release forms will need to be scanned to be submitted.
- The online submission system will go live October 2, 2023. All PSAs and included forms must be submitted by January 8, 2024.
- Your video submission must be in .mp4 format.
- Videos must not contain copyright-protected content (e.g., music, clips from films or television shows, etc.). Stock and royalty-free images, videos, and music can be used.
- "CTE Month®" or "Career and Technical Education Month®" must be followed by the trademark sign (®) the first time it appears in a document or visual presentation.

Can educators help with their students' project?

Educators may advise students, but should not take on a significant role in creating the PSA.
